Purpose:

This Agreement governs the use and licensing of the Bootstrap Login Form (the “Form”) designed and provided by the Developer. User is responsible for securing and maintaining all passwords and account information related to the Form.

Limitation of Liability:

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, United States, without regard to its conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.
