## **Acknowledgment and Responsibilities:**

I, the undersigned Bridesmaid, acknowledge my commitment to participate in the wedding events and to fulfill the duties assigned to me with respect, punctuality, and enthusiasm. I understand that my involvement includes attendance at pre-wedding activities, the rehearsal, the wedding ceremony, and any related responsibilities as agreed upon with the Bride.

## **Dress and Attire Agreement:**

I agree to wear the designated attire chosen by the Bride or her appointed representative. I understand that I am responsible for the cost, care, and timely return (if applicable) of the attire. I acknowledge that alterations may be necessary and agree to assist in timely fittings and adjustments.

## **Travel and Accommodation:**

I understand that travel and accommodation arrangements and expenses are my responsibility unless otherwise agreed in writing. I commit to communicating promptly about any constraints or scheduling conflicts affecting my participation.

## **Liability and Indemnity:**

I release and hold harmless the Bride, the Groom, their families, agents, and representatives from any liability arising from my participation in wedding-related events, including but not limited to injury, property damage, or loss. I agree to indemnify and defend them against any claims arising from my actions or omissions.

## **Confidentiality:**

I agree to keep confidential all private information shared within the bridal party and not to disclose any sensitive details about the wedding or personal matters discussed during the planning process, except as required by law.

## **Health and Safety:**

I certify that I am physically and mentally able to participate in all wedding events and activities. I agree to notify the Bride of any condition or circumstance that might affect my participation. I will comply with all applicable health and safety guidelines during the events.

## **Termination of Participation:**

The Bride reserves the right to revoke this agreement and terminate my participation as Bridesmaid at any time for cause, including but not limited to breach of this Agreement, unbecoming conduct, or failure to fulfill responsibilities. In such case, I agree to promptly return any bridal party materials or attire.

**Dispute Resolution:**

Any disputes arising from or related to this Agreement shall be resolved by binding arbitration in accordance with the rules of the American Arbitration Association. This Agreement shall be governed by and construed in accordance with the laws of the United States and the state where the wedding is held.

**Entire Agreement and Amendment:**

This Agreement constitutes the entire understanding between the parties concerning the Bridesmaid's participation and supersedes all prior discussions or agreements. Any amendments must be in writing and signed by both parties.
