Discharge Authorization and Release:

By signing below, Owner/Principal hereby authorizes the above-named Authorized Agent or Representative to take all necessary actions to discharge, remove, transport, or otherwise handle the Vessel described herein from any location(s) specified by Owner/Principal. Owner/Principal represents and warrants that they have full authority and legal right to grant such authorization and release all claims, liabilities, and damages against any party acting under this authorization. This authorization shall be effective until expressly revoked in writing by Owner/Principal. Owner/Principal agrees to indemnify and hold harmless the Authorized Agent, third party contractors, transporters, and any other involved parties from and against any claims, causes of action, damages, or expenses arising from or related to the discharge and handling of the Vessel pursuant to this authorization.

Terms and Conditions:

1. Authority and Compliance

The Owner/Principal represents that this authorization complies with all applicable federal, state, and local laws, including but not limited to maritime, environmental, and safety regulations. The Authorized Agent shall perform all actions in compliance with such laws.

2. Liability Limitation

Owner/Principal acknowledges that the Authorized Agent and related parties shall not be liable for any loss, damage, delay, or expense arising from causes beyond their reasonable control, including but not limited to acts of God, accidents, theft, or third party actions.

3. Indemnification

Owner/Principal agrees to indemnify, defend, and hold harmless the Authorized Agent and related parties from any claims, damages, liabilities, costs, or expenses (including attorneys' fees) arising out of or related to the Vessel discharge or handling under this authorization.

4. Release of Claims

Owner/Principal releases any and all claims against the Authorized Agent and related parties for any loss or damage to the Vessel or property during discharge, transportation, or storage, except to the extent caused by gross negligence or willful misconduct.

5. No Warranty on Condition

The Authorized Agent makes no warranty or representation regarding the condition of the Vessel before, during, or after discharge or transportation. Owner/Principal accepts the Vessel AS-IS.

6. Governing Law and Venue

This Authorization and Release shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. The parties agree that any disputes shall be resolved exclusively in the state or federal courts located in _____ County, _____.

7. Severability

If any provision of this Authorization is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

8. Entire Agreement

This Authorization constitutes the entire agreement between the parties with respect to the subject matter hereof, superseding all prior agreements, understandings, or representations.

9. Execution and Counterparts

This Authorization may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one instrument. Electronic or PDF signatures shall be deemed as valid as original signatures.
