Event Participation Agreement:

I, the undersigned participant, acknowledge that participation in the event involves inherent risks, including but not limited to physical injury, illness, or property damage. I certify that I am physically fit and have not been advised otherwise by a qualified medical professional. I voluntarily assume all risks associated with participation in this event and agree to comply with all rules and instructions provided by the event organizers.

Liability Waiver and Release:

To the maximum extent permitted by law, I hereby release, waive, discharge, and covenant not to sue the event organizers, sponsors, volunteers, and any affiliated entities (collectively, the "Releasees") from any and all liability, claims, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or to any property belonging to me, whether caused by the negligence of the Releasees or otherwise, while participating in the event or while in, on, or upon the premises where the event is being conducted.

Indemnification:

I agree to indemnify, defend, and hold harmless the Releasees from and against any and all claims, damages, losses, and expenses, including attorneys' fees, arising out of or resulting from my participation in the event, including any claims brought by third parties resulting from my own negligent or intentional acts.

Medical Authorization:

In the event of an emergency, I authorize the event organizers and medical personnel to provide or arrange for emergency medical treatment deemed necessary for my health and safety. I understand that I am solely responsible for all costs related to such medical treatment and transportation.

Photography and Publicity Release:

I grant permission to the event organizers and their agents to take and use photographs, video, or other media of me during the event for promotional, educational, or commercial purposes in any manner or media without compensation or approval rights.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state law where the event takes place, without regard to its conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located within the applicable jurisdiction.

Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral, relating to such subject matter.
