## Clause 1 – Agreement to Purchase

## Clause 2 – Payment Terms

Full payment must be made prior to or at the time of order placement. Payments via credit card, check, or other accepted methods shall be processed in accordance with Seller's policies.

## Clause 3 – Delivery

Seller shall deliver the gift basket(s) on the requested delivery date to the recipient information provided, subject to availability and weather conditions. Seller is not liable for delivery delays beyond its control.

## Clause 4 – Cancellation and Refunds

Orders may be canceled by the Customer only if requested at least 48 hours before the scheduled delivery date. Refunds, if any, will be processed in accordance with Seller's refund policy and applicable law.

## Clause 5 – Liability

Seller is not responsible for any damages arising from the use or consumption of the contents of the gift basket(s). Customer assumes all risks associated with allergies or sensitivities.

**Clause 6 – Privacy**

Customer’s personal information will be used solely for the purposes of order fulfillment and compliance with applicable laws. Seller shall maintain reasonable safeguards to protect such information.

**Clause 7 – Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of the United States and the state in which Seller operates. Any disputes shall be subject to the exclusive jurisdiction of the courts located therein.

**Clause 8 – Entire Agreement**

This document constitutes the entire agreement between Customer and Seller with respect to the purchase and delivery of gift basket(s). Any amendments must be in writing and signed by both parties.

**Clause 9 – Severability**

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Clause 10 – Acceptance**
