Clause 1 – Eligibility

Participants must be at least 18 years old unless accompanied by a parent or legal guardian. All participants must have a valid USGA Handicap Index or demonstrate sufficient playing ability.

Clause 2 – Registration and Payment

Registration is not complete until payment in full has been received. Fees are non-refundable except as explicitly provided in this Agreement or at the discretion of the Tournament Organizer.

Clause 3 – Code of Conduct

Participants agree to abide by the rules of golf as established by the United States Golf Association (USGA) and to conduct themselves in a sportsmanlike manner at all times during the tournament and related events.

Clause 4 – Liability Waiver

Participants assume all risk of injury, loss, or damage to personal property arising out of participation in the tournament. The Tournament Organizer, sponsors, and host venues shall not be liable for any injury, loss, or damage sustained.

Clause 5 – Medical Treatment Authorization

In case of emergency, participants authorize the Tournament Organizer to obtain medical treatment on their behalf. Participants shall be responsible for all costs associated with such treatment.

Clause 6 – Privacy and Use of Personal Information

Personal information collected during registration will be used solely for tournament administration and communication. Participants consent to such use and to receiving communications related to this event.

Clause 7 – Media Release

Participants grant permission to the Tournament Organizer to use photographs, videos, and other media recordings taken during the event for promotional and marketing purposes without compensation.

Clause 8 – Dispute Resolution

Any disputes arising under this Agreement shall be resolved through binding arbitration in accordance with the rules of the American Arbitration Association, held within the jurisdiction of the tournament venue.

Clause 9 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflicts of law principles.

Clause 10 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain fully effective and enforceable.

Clause 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties relating to the subject matter hereof and supersedes all prior agreements or understandings.

Clause 12 – Signature and Acceptance
