5. Warranty

Service Provider warrants labor on the performed services for a period of 90 days from completion. Parts are subject to manufacturer warranties only. This warranty does not cover damages resulting from misuse, negligence, or unauthorized repairs.

6. Limitation of Liability

Service Provider shall not be liable for any indirect, incidental, or consequential damages arising out of or related to the services performed. The maximum liability shall be limited to the amount paid for the specific service.

7. Client Obligations

Client shall provide access to the service location, necessary utilities, and information required for Service Provider to perform the work safely and effectively.

8. Termination

Either party may terminate this agreement with written notice. Client remains responsible for payment for all services performed prior to termination.

9. Governing Law and Jurisdiction
